**Re: "Postcards from the Rez"**

**This letter supercedes and replaces our letter dated March 27, 2007**

Dear George:

This letter will confirm APTN's commitment of [REDACTED] in the form of a broadcast licence fee towards the production of the 1 part, 30 minute, English-language HD version(s) of the lifestyle pilot "Postcards from the Rez", which will be certified as a Canadian production. The broadcast licence fee from our 2006/7 fiscal year will be payable in installments over the course of the production.

APTN acknowledges that this program is being funded without assistance from Canadian Television Fund/Telefilm, ALI, or APTN's CTF BPE. Program may be funded using BPE assigned from other broadcasters.

In consideration of the broadcast licence fee, APTN will receive the following:

1. First and exclusive Canadian telecast rights in English, with exclusivity limited to twelve (12) months.
2. Aboriginal language segments (if any) in the English-language version are to be translated and delivered either dubbed or subtitled in English.
3. Unlimited playdates over a five (5) year period, commencing upon the first telecast of the program.
4. Delivered on Beta SP/SX and HDCam with English closed-captioning for the hearing-impaired.
5. Rough cuts and fine cuts to be delivered to APTN on DVD for consideration and approval.
6. Assurances that Aboriginal production personnel will be consulted and utilized when possible including both above and below the line training and mentorship positions.
7. Credit in credit roll, printed materials and electronic media to read: "Produced in Association with APTN – the Aboriginal Peoples Television Network" or similar wording as agreed to.
8. Approval by APTN of key creative elements: writers, directors, final script outline, cast, key production personnel; and key production elements: final budget, production schedule and evidence of full financing, including completion guarantee and insurance, if required by APTN.

Sharing our stories with all Canadians.

This offer is subject to the following conditions in favour of APTN, all of which must be satisfied on or before **September 28, 2007**, failing which this offer will be null and void, and the arrangements contemplated herein will terminate without liability to either party:

1. Written acceptance of this offer by you (if such acceptance is not indicated below);
2. Finalization by you and approval by APTN of key creative and production elements, final budget and production schedule; and
3. Confirmation by you to APTN's satisfaction of the availability of full financing from all sources, in an amount that is not less than the total of the final locked production budget as approved by APTN.

Please note that E & O insurance will generally be required by APTN.

This offer and the arrangements contemplated herein are also subject to the successful negotiation of the formal APTN Long Form Program Production and Licence Agreement (the "PPLA"), which must be completed before the advance of any portion of the broadcast licence fee. If, for any reason, the PPLA is not completed by you and APTN on or before the first scheduled day (as approved by APTN) of principal photography, then this offer and the arrangements contemplated herein will automatically terminate without liability to either party.

Assuming the project goes forward into a formal PPLA, APTN would intend to broadcast the completed program within 18 months of delivery to APTN.

By accepting this offer, you acknowledge and agree that any costs, expenditures or commitments incurred or made by you prior to the completion of the PPLA are incurred or made at your sole risk, and that APTN will have no liability in connection with such costs, expenditures or commitments.

Any amendment to this offer, or waiver or variation of any condition provided for herein must be in writing and signed by a representative of each of the parties hereto.

Thank you for bringing this project to APTN. We look forward to the opportunity in presenting "**Postcards from the Rez**" to our viewers.
